THE SERVICE PROVIDER AND THE CLIENT HAVE AGREED:



2. T erms of the reimbursement of the Loan, interest and other sums under the Loan agreement established in this Annex is valid and obligatory to the Client (**PILOT MANAGEMENT SERVICES** (**CYPRUS) LTD**) only if the Service provider duly provides Services and timely fulfill all his duties under Service agreement and also timely and properly fulfill all his duties under Loan agreement.



SERVICES (CYPRUS) LTD shall have the right unilaterally without informing to set-off the undertakings.
4. If the Deposit will be used for the reimbursement of the fines, interest and/or compensation of the damage incurred according to the Loan agreement or Service agreement, then shall immediately repay the Deposit to PILOT MANAGEMENT SERVICES (CYPRUS) LTD. If the sum of the Deposit will be not restored (not paid to PILOT MANAGEMENT SERVICES (CYPRUS) LTD account) during 10 business days after appropriate request was submitted to then PILOT MANAGEMENT SERVICES (CYPRUS) LTD will have the right to change the Loan repayment schedule or unilaterally without notice and without applying to the court to terminate the Loan Agreement and Service agreement (including this Annex) and to demand from immediately not later than within 1 business day to reimburse all actually disbursed sum of the Loan and to pay all Interest to the PILOT MANAGEMENT SERVICES (CYPRUS) LTD as well to pay fine equal to 10 000 EUR, which by the mutual agreement of the Parties is considered as minimum damages of PILOT MANAGEMENT SERVICES (CYPRUS) LTD that shall not be proven.
